upon the creed and behaviour of Muslims when accepted and followed, blindly, without scrutiny.

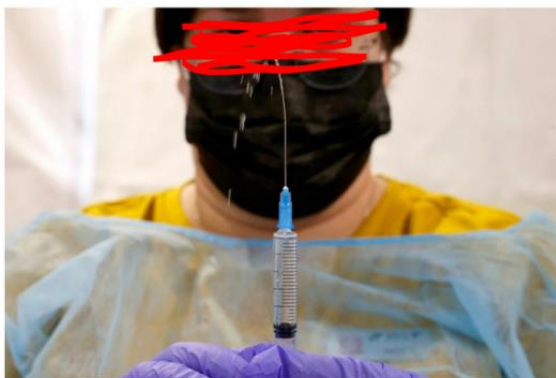

#### We Must Start Planning For a Permanent Pandemic

It is important that the reader reads **all previous parts** in this series to have the full background context for this article.

The article<sup>1</sup> is from Bloomberg.Com, a major globalist player, and it sets out the vision of the **Darwinian Socialist Eugenicists**, the **Collectivists**, the **modern-day Mazdakists**, the enemies of Allāh (عَزَّوَجَلَّ), who wish to abolish private property rights as a means of enslaving men, women, societies and nations. Once complete control is gained over the lives and properties of people, it is then that tyrants start to command, forbid and enforce their materialist religion on subjects while desecrating religion. Do not think that the way of the Chinese Communists towards Muslims is only a remote possibility in Socialist Democracies.

“Social democracy” is simply the slow, subtle way to Communism, Collectivism, the abolition of private property and it has been redesigned and rebranded for the 21st century with deceptive, alluring slogans to trick nations, with tremendous leverage from technology.

A pathogen’s evolution is neither surprising nor automatically worrisome. One frequent pattern is that bugs over time become more contagious but less virulent. After all, not killing your host too efficiently confers an advantage in natural selection. If SARS-CoV-2 goes this route, it’ll eventually become just another common cold.

But that’s not what it’s been doing recently. The variants we know of have become more infectious, but no less lethal. From

an epidemiological point of view, that’s the worst news.

Consider two alternative evolutionary paths. In one, a virus becomes more severe but not more transmissible. It will cause more disease and death, but the growth is linear. In the other path, a mutating virus becomes neither more nor less virulent but more contagious. It will cause increases in disease and death that are exponential rather than linear. Adam Kucharski at the London School of Hygiene and Tropical Medicine explains the math here.

If this is the evolutionary trajectory of SARS-CoV-2, we’re in for seemingly endless cycles of outbreaks and remissions, social restrictions and relaxations, lockdowns and reopenings. At least in rich countries, we will probably get vaccinated a couple of times a year, against the latest variant in circulation, but never fast or comprehensively enough to achieve herd immunity.

## COMMENTS

As stated earlier, if you have read all previous parts in this series, you won’t really need much commentary, but for the sake of repetition as reminder and revision, we can say the following:

**1.** The principles evident in Allāh’s creation, emanating from His names and attributes and actions are, among many things: **precision, beauty, coherence, wisdom, cooperation, balance, moderation, symbiosis, meaningful end-goals** and so on, all of which evidence His precise handiwork.

Upon this, all types of **acute (short-term) illnesses** are nothing but in-built healing and repair mechanisms that have been pre-programmed into the body, they are from the sum of the body’s

strengths (quwā) through which it is rendered a self-healing, self-regenerating system—this being indicative of Allāh being **al-Muhyī** (the Giver of Life), **al-Mumīt** (the Taker of Life) and **al-Shāfi** (the True Healer).

These short term illnesses comprise a natural resolution of prior irregularities or violations that led to a departure from homeostasis. The goal of a physician is to ease the passing of this illness by supporting the body to do so, and the true Healer is Allāh (عَزَّوَجَلَّ), since He is the creator, the placer and determiner of these in-built mechanisms of repair and healing.

However, in some people, this in-built ability of the body to self-heal becomes impaired and compromised due to numerous factors such as malnutrition, poisoning, toxicity of various forms, violations in diet, habits, lifestyle and so on. This leads to **chronic (long-term) illness** where they body is unable to complete the repair and healing process in a timely and efficient manner by either overreacting or underreacting.

These types of illnesses have increased greatly in the last century and the fault lies with man, his violations and abuses and moving away from what is **natural** and **wholesome** to what is **artificial**, **deficient** and **toxic**, and this includes the arena of medication itself. So the blame here for increase in disease and death is upon man and his actions, not upon the Creator, who created man upon fiṭrah as it relates to his religion and sound constitution and vitality as it relates to his body.

In contrast to the above, we have the modern atheistic, materialistic narrative:

This is the notion of there being some sort of inherent battle, war, competition, struggle within biological life for survival, and this itself being the driving force for all biological life, novelty and

evolution. This is the saying of the people of kufr and ilhād, of the materialists, atheists, it is not the saying of the Muslims.

This notion drives many of the sciences of the disbelievers and has been infused into them in inextricable ways.

Illnesses are a result of such struggles between “viruses”, bacteria and cells, and man is always in constant danger of the consequences of natural selection, through which he himself came about. Because his creation is haphazard, undirected and imperfect, he remains vulnerable to attack from “viruses” due to his flawed constitution, and they are always mutating and finding ways to gain an evolutionary advantage.

The threat of viruses—which according to one of their theories, are the primary source for the emergence and evolution of life itself—constantly looms over his head.

Thus, man himself must teach the body to be prepared for such threats by engaging in “self-directed evolution” to patch up the flaws in his haphazard creation.

This notion forms the basis of their perception and presentation of the virus as an evolving primary disease causing agent and grave threat, an issue in which they are misguided, but which they have, very sadly, been blindly-followed by Muslims.

**2.** The intent behind this Bloomberg propaganda piece—and there are many more like it, constantly being published—is to prepare people, whole nations and governments for the Darwinian scam of virus “mutants” and “variants” and through this ruse, make them willingly surrender more and more of their sovereignty, step by step, to arrive at full global governance, whereafter nations that don’t comply with policies can be coerced and punished by the collective.

**As we have said previously, if you buy the first lie, you are going to have to buy every lie thereafter and in some cases, at the expense of harming creed, as well as losing various rights and numerous degrees of freedom because of those lies.**

3. “Virology” is a pseudoscience and the notion of a “pathogenic virus” is an abstraction of the mind having no existence in physical reality. Death and disease, such as what happens through colds, flus, pneumonia and so on do not require a “virus” in order to be explained at the molecular level.

The components of what they wrongly present as a “virus”, such as **genetic fragments, glycoproteins** (serving various roles) and **envelopes** do exist in the body and have functions, but they have been **incorrectly abstracted** into a “virus” by fanatical germ theorists whose ideas were already discredited and disproven by the mid-20th century. In essence, this is a dispute over what we label things and how we describe processes and their meanings and true purposes. The “virus” narrative is an extraneous ideological layer that has been added through a misinterpretation and misunderstanding of the physical, biological layer.

Genetic breakdown products and glycoproteins that are released from the body during pre-programmed cleansing, repairing, detox mechanisms—such as colds, flus by way of example—are picked up in samples and constructed theoretically into “viruses” and their alleged genomes with the use of computer software. All of these genomes are “**in silico**” only, this is one of their terms, and it means “as existing on computer”. It is not an actual genome.

At no stage is a whole, intact virus ever purified and isolated from everything else and then studied, characterised. Any pictures

that are shown are of microvesicles or particles which are simply the end result of cell breakdown and death.

Virologists conduct what is in reality **science fraud** in the laboratory. They do not do science, but something similar to what magicians do on stage. Instead of isolating and purifying the alleged “virus” from a sample—with the common, dictionary meanings of these words—and working with a pure sample for the purpose of accurate characterisation, they poison and starve **monkey kidney cells** to which they add a patient sample which they believe contains the alleged “virus”. **These cells become malformed due to the stress created by the experimental procedure itself and not from the added patient sample.**

These science fraudsters never do control experiments to determine whether the experimental procedure is creating the effect or their alleged “virus” in the added patient sample.

If the severity of starvation and poisoning is high enough, the cells break down and basically “explode” into tiny particles (microvesicles) or fragments composed of genetic fragments, lipid membranes and proteins, and these are combined in the mind and interpreted as the “virus”, when they are nothing but end-products of cell death.

If the science fraudsters are unable to detect their imagined “virus” despite poisoning and starvation of the cells, they continue to poison or stress the cells more and more until they see what they want to see. One of their techniques is to add the proteolytic enzyme called Trypsin which leads to further degradation and breakdown. It is these breakdown particles and fragments that are claimed by the science fraudsters to be an external “pathogenic virus” and in reality, it is nothing but the breakdown products of cell death which they have abstracted into a “virus”.

The outcome of the experimental procedure is turned into the cause. It is like deliberately burning a building down and then claiming that the remaining debris and firemen that turned up to put it out were the cause of the fire. This would never be accepted by any sane person. But this is what science fraudsters known as “virologists” do in laboratories all across the world. Many of them are just blind-followers of procedures and processes and never think to question the scientific validity of what they are doing.

Further, because of **the dynamic nature of DNA**, there will always be variations in genetic sequences of breakdown fragments, whether in samples from different people, or in the same person taken at different times. Alongside the use of PCR fraud and the selective use of primers to engineer the result that one seeks, these can be very easily presented as “variants” and “mutations” within Darwinian evolutionary pseudoscience to maintain the myth and superstition of Darwinian viral contagion.

All genomes and alleged “variants”, “mutants” exist only on computer, they do not correlate with physical reality and are merely theoretical constructions.

No evidence exists anywhere in the world with any nation, government, health authority, laboratory, or private corporation for the proper isolation and purification of a single virus and genuine scientific evidence following the true scientific method that this alleged virus is the primary cause of disease.

No scientific paper exists in history that has presented genuine scientific evidence, inclusive of controls, to prove this. Any and all papers claimed to do so by blind-followers and the brainwashed can be readily dismantled and taken apart.

**4. Arguing against all the above through prior blind-following and indoctrination in order to support the Darwinian virus**



narrative will be futile. It makes no difference if you are highly-educated, holding a doctorate, a degree, certificates, credentials or just a common person or someone in-between.

Don't attempt it. You will fail. The evidence will crush you, and what you think to be evidence will be exposed as nothing but a mirage in the desert.

Further, referring to honest, credible scientists and microbiologists who believe in the virus narrative and operate on that basis and have built careers on top of it will not aid you either, as they are also mistaken.

Evidence has been firmly established in that respect and even they are unable provide evidence meeting the standards of true scientific inquiry and the scientific method. They are victims of misunderstandings and misinterpretations from the last century.

If you find this hard to understand, then consider the innovated creeds in Islām such as those of the Jahmiyyah, Mu'tazilah, Ash'ariyyah and others. While they may have a lot of internal coherence and to those holding them they may explain everything coherently and consistently, they are nevertheless false, because they are founded on false premises and principles. The same applies in worldly sciences. People can misunderstand revelation, despite internal coherence existing in their misunderstanding. And likewise, people can misunderstand the workings of creation, despite internal coherence in their theories and models.

It is thus with the pseudoscience of Virology. Many intelligent people are its victims and taqlīd is not knowledge, neither in religion, nor in worldly sciences.

If you do try to argue, then know that the similitude for you in the worldly sciences will be just as the common person is deceived by the likes of al-Kawthari or Saqqāf in religious

sciences, as one who tries to use their lies and frauds in vain to justify a misguided position that opposes revelation.

In the same way, if you try to resist and argue, you will end up being exposed as a victim of the speculative materialist pseudosciences of the atheists, the Darwinists, the materialists and their distortion, misrepresentation and incorrect framing of what Allāh has created, and of what He has placed in the body of quwā (strengths) and ṭabāʾīʿ (properties). All of this—in terms of its meanings, workings, wisdoms and end-goals—being tied to His Names al-Shāfi, al-Muḥyī, al-Mumīt and His description, al-Ṭabīb, the lofty meanings and wisdoms thereof having been stripped away by the fabrications and fables of the Darwinian Eugenicist Socialist Materialists.

The above is said in the same way it is said to a Jahmī Muʿawwil: I give you three years to find me a single authentic instance from a single one of the Salaf making taʿwīl of a single verse pertaining to the attributes upon the principles you claim. He will not be successful, not even if you gave him three hundred years.

Similarly, the virologist cannot bring a purified sample of any alleged whole, intact, “infectious” virus through which he can demonstrate, through truly scientific methods, that it is the cause of disease, because no such thing exists. It is a figment of the imagination propped up by sleight of hand trickery, just like the dīn of the Jahmī Muʿawwil is propped up by sleight of hand linguistics.

Yes, there are genetic fragments, yes there are glycoproteins, yes, there are microvesicles and particles. However, their workings in disease processes have been misunderstood and misrepresented by fanatical germ theorists who could not let go of their discredited ideas from the early 20th century. They

imposed the doctrine of the “virus” on to physical processes. They have found the “virus” dogma to be extremely profitable and that is the main reason why this superstition remains to this day.

This Darwinian virus narrative allows for baseless actions and behaviours to be justified which actually exceed the limits, enter people into omens, superstition and oppression, and which clash with what the Messenger (ﷺ) brought in terms of guidance in this arena.

In short, everything you need to know in this arena emanates from three names of Allāh, al-Muḥyī, al-Mumīt and al-Shāfi. Thus, at the most basic level, the unit of life level, there is either regeneration of new cells or dissolution and removal of dead or damaged cells. There are complex, sophisticated in-built processes that manage all of that in accordance with Allāh’s decree, keeping in mind that we are not accounting for the soul in this matter, which is another layer.

The study and interpretation of these processes at the molecular level is subjective and one can impose theories and models to suit a particular doctrine, ideology or narrative.

Today, it is the Atheist, Materialist, Darwinian Socialist Eugenicists who dominate this arena, and it is their doctrine that the people of earth have been fed with.

**5.** Bloomberg is an important player in the **Great Reset** plan, the **New Normal** agenda and within its articles, editorials and pieces one can find the script laid bare.

Take this paragraph for example: **“If this is the evolutionary trajectory of SARS-CoV-2, we’re in for seemingly endless cycles of outbreaks and remissions, social restrictions and relaxations, lockdowns and reopenings. At least in rich countries, we will probably get vaccinated a couple of times a**

**year, against the latest variant in circulation, but never fast or comprehensively enough to achieve herd immunity.”**

Here, Bloomberg is giving you a vision of the future, of what is to come and what has been planned. In fact, its already playing out right now, in front of our eyes. There are great lies in this paragraph and lies against the workings of Allāh’s creation. A separate article would be needed to explain them in detail.

“Herd immunity” is a fictitious and fallacious concept to begin with, no such thing exists. But they try to present the notion that only injections can provide this fictitious “herd immunity”, implying that the body is incapable, on its own, to regain health, to self-repair, to heal, and needs an injection for it to be trained to achieve something its haphazard creation through neo-Darwinian evolution—mutation and natural selection—was unable to give it, and hence, now that we have the knowledge and know-how to do “self-directed evolution”, man must be actively engaged in evolving, shaping and improving on his haphazard creation.

Anything which is “natural” to them—meaning, within their belief, a product of evolution, not having been tinkered with by man [which is how they speak about what is, to us, created by Allāh]—is deficient, badly-designed, flawed and can be perfected.

This is from the great lies pushed by the WHO and the criminal pharmaceutical corporations and business and other ideological interests that fund, control and direct it.

Retorting with: “But, I believe this is how Allāh does it, it is Allāh who causes these mutations” is not going to help you. This statement does not comprise any proof in itself and will not somehow validate and prove the superstitious belief in the Darwinian virus and its mutations and variants.
