What makes this clear is that sins (sayyi'āt, dhunūb) are diseases of the heart, just as fever and ailments are diseases of the body. It is then placed into families through given nomenclatures. No proof exists whatsoever that an alleged "virus" is the cause of any disease with what meets the standards of the scientific method in proving cause and effect. Virology became a pseudoscience in the 1950s, after the viral causation of disease could not be proven in the decades earlier through other routes.

And thus, we are in constant evolutionary struggle against invisible enemies that can develop "superpowers", that we must engage in "self-directed evolution" to eliminate the flaws in man's creation, his vulnerability within the ongoing struggles and pressures of evolution.

For the **Muwaḥḥid**, these short-term, emergency foreground programs are in-built repair and healing mechanisms indicative of the rubūbiyyah (lordship) of Allāh (مَرَيَحَلَ) who is the Healer (**al-Shāfī**) and the knower of all diseases and cures and the one powerful over health and healing (**al-Ṭabīb**).<sup>3</sup> For healthy people these programs are just some days of mild discomfort. They remove toxins, accumulated waste and morbid materials, and replace damaged or compromised mucosal linings in the respiratory tract.

What have been wrongly labelled as "viruses" historically speaking by the misguided germ theorists<sup>4</sup> are in reality:

So they come in orderto

-communications messengers (like cell to cell SMS/email) and transport vehicles (like a courier/taxi) that can be involved in the execution of repair and normalisation programs, and

-genetic fragments which are breakdown products of dead or damaged cells and their organelles. They are prepared for elimination through various routes, after having been enclosed in fat, with lipid bilayers, to isolate and seal them off. They are then engulfed by elements of the "immune network" such as phagocytes for transportation out of the system.

Ordinarily speaking, latent background programs that take care of this internal clean-up and clearance process would be running efficiently and a healthy person would not know.

However, the lower the vitality of the person—with low nutritional status being one of the factors<sup>5</sup>—the more severe the symptoms of the emergency programs when the body executes them by way of necessity. As the program is running its course in the foreground, the body will expel what needs expelling of toxins, morbid and waste materials, inclusive of these communications and transport messengers that are used up in the process. **Within the sum of all of this material is a large hotch-potch of genetic debris, completely dead, inert**. Genetic fragments are picked up and wrongly interpreted as external, disease-causing viruses.

There is no such thing as a whole, intact "infectious virus" present in the air or in any sample and its existence is

demonstrated only through sleight of hand tricks in the laboratory using indirect methods. Direct detection—and thus isolation, purification, proper characterisation and scientifically valid proof of disease causation of a virus—is not possible.<sup>6</sup>

No government, no institution, no university, or laboratory anywhere in the world has a single millilitre vial of <u>completely</u> <u>purified</u>, whole, intact, "infectious" virus, absent all other materials and contaminants. If they do, I will be happy to put it in a glass and drink it all, or rub it in my mouth, nose and eyes.

It may be hard for people to accept that they have had the wool pulled over their eyes, but if they just pause and think upon the saying of Shaykh al-Islām Muḥammad bin ʿAbd al-Wahhāb (زحيثائلة) with respect to Tawḥīd and other foundations of religion:

When samples are taken from the nose, throat or lungs of people, *it is never a whole virus which is being detected*, but very small fragments of broken down genetic material. The true origin of this material is never known, however it is ascribed to a "virus". No intact, whole virus is ever detected at any stage, let alone *purified* in the proper sense of the word. As such, the claim that a "virus" is the root cause of disease has never been proven through scientifically valid experiments. There is trickery and deception in the techniques and procedures used to make these claims about viruses, and this has been explained in detail elsewhere. So when it is the case that learned, shrewd people can err in the matter of Tawhīd, as has happened in history, among many of the intelligent people of Kalām and the Ṣūfiyyyah and others, despite it being rooted in fiṭrah, and 'aql and despite it being as clear as daylight in revelation, how can a person deny that the disbelievers can likewise be utterly misguided as it relates to the matter of Allāh's Rubūbiyyah, His creation, its workings, its true meanings, purposes and significance?

Especially given the fact that they have stripped the creation from having a Creator, from it being tied to the names, attributes and actions of the Creator, and they blindly reconstruct their knowledge and understanding of Allāh's creation upon the principles of their shirk and kufr in which they received inspiration from Iblīs.

The sayings published in the newspapers of the disbelievers and polytheists—and which may be blindly-followed and repeated by others— that the, "**Kent variant has developed a super power**" and that the "**virus evolves**" and intelligently "**evades**" the immune system and more of this type of speech, all of this is founded upon their shirk and kufr and upon stripping the creation from having a Creator.

Any Muslim who subscribes to these statements, these ideas, accommodates them and believes them and thinks that the disbelievers are upon something and that they are upon haqq and sīdq (truth and honesty) in what they are saying, then he is mistaken and has been deceived by the machinations of Iblīs and his hosts among the people of disbelief.

The disbelievers—as they roll out the mRNA injection which primes the immune system for hyper-reaction at some point in the future—are spreading lies and fabrications of a new deadly "superpower" virus built upon their false, superstitious evolutionary, viral causation doctrine to instill fear and in order to pursue their agendas.

#### A quote from the Express article of 2 February 2021: Sky News correspondent Thomas Moore said: "It's developed a superpower."

"Superpower mutants" will be claimed to be the cause of the next round of engineered disease and death. They can repeat the same cycle of deception over and over again. Once the initial lie is bought, there is no end to the lies that follow.

Any person who believes this lie that <u>completely and utterly</u> <u>lifeless, dead, inert pieces of broken down genetic fragments</u> expelled by the body have somehow developed "superpowers" needs serious help, a serious wake up call. Those who need this wake up call the most are Muslim physicians because they hold considerable sway over populations.

As for the disease and death taking place, it is explained by:

a) The destructive lockdown measures themselves and shutting down of essential health care services leading to premature deaths of the chronically ill and elderly.

b) Recategorisation and rebranding of existing, known diseases and symptoms including the seasonal flu and the usual annual death burden into "COVID-19" through the fraudulent PCR "test". This massively inflates the number of deaths allegedly caused by the "virus" and is also used to turn healthy, disease and symptom-free people into "cases", which in turn drives fear propaganda and psychological warfare. They claim that in 2020, the "flu" (and its alleged virus) almost disappeared all across the world. This is only believed by the naive and ignorant. Rather, the "flu" has been renamed as "COVID-19" as have many other disease conditions and symptoms.

c) Sick people being killed (murdered and euthanised) through maltreatment, do not resuscitate (DNR) notices slapped on the elderly and those considered unfit, prematurely putting people on intubation/ventilation, giving wrong medication or withholding of appropriate medication and so on.

And from this point onwards, we must also add:

d) The administration of mRNA gene therapy via injection to prime the "immune system" for hyper-reactivity. It is already killing many people in care homes and beyond—[these deaths are being deceptively marked as "COVID-19" deaths]—while setting many healthy people up for severe disease at some point in the future.<sup>7</sup> This occurs by a skewing of the "immune system" after sensitizing it to proteins that are part of the complex

communications and cellular entry, exit and fusion systems running in the body.

And from Allāh is aid sought.

We finish by repeating what we stated in the article from Ibn al-Qayyim on sneezing:  $^{\rm 8}$ 

The alleged virus has been animated and given qualities and properties, [rather, superpowers], on the basis of which people are led to exaggeration, fear and superstition.

All of this is very different from the conception that the body has been created upon balance, homeostasis, equilibrium and violations in diet, habits and lifestyle can lead to the execution of short-term emergency programs, and that the root causes of disease return back fundamentally to:<sup>9</sup>

-deficiency in essential nutrients, vitamins, minerals,

-toxicity from the environment,

—accumulation of excess morbid and waste materials,
—enervation.

So when that happens, the foreground programs are triggered as a corrective, normalisation program and there are seasonal stimuli, like the winter or sudden cold weather, that can act as triggers. For healthy people this is some days of mild discomfort and for others, the passing of symptoms can be eased by addressing any nutritional deficiencies such as vitamins C and D, Zinc, Selenium and others which lead to better modulation of the repair program and to easing—not

hindering or blocking—of the symptoms, which are preprogrammed mechanisms.

And for the elderly, chronically sick or immune damaged people, it might top them over the edge, despite all reasonable interventions.

Yet, in all of this, there is no notion or concept of any "virus", it is not even needed, and there does not remain any ground for superstition to arise and settle in the hearts, because a "virus" is totally out of the picture. It is not needed to explain anything because there is zero proof for the viral causation theory of disease.<sup>10</sup>

All that has happened is that genetic fragments which are cellular breakdown products have been wrongly labelled as "viruses" and various microvesicles coming in and out of cells have been confused for "viruses" and assumed to be diseasecausing agents without a shred of valid scientific evidence. The mistake is similar to claiming that firemen are the cause of the fire because they are routinely observed coming in and out of burning buildings. While they are certainly present and on the scene, they are not the root cause of the fire.

Further, even in cases where people have been immune damaged due to medication, prior vaccination or other causes, they can become victims of an overreactive, hyper immune response. These types of situations warrant particular courses of emergency action [for the preservation of life] about which there would not be much disagreement. However, it would still be a matter of interpretation of events. In these scenarios, there is still no need for invoking any alleged, external disease causing "virus" as the root cause of disease.

The label of "virus" is a misnomer, it is a mistake that was

made historically by misguided germ theorists trying to validate their theories of disease causation, in which they failed miserably, until sleight of hand techniques were used in the 1950s to create the illusion of viral disease causation, and then exaggerating in that to exclude or downplay the true foundational causes of disease.
