We have remarked often, **that if you buy the initial lie, you are going to have to swallow every other lie that follows on from it** and herein lies the great danger in trusting the people of disbelief in their speculative sciences, especially given that they are founded upon materialism, atheism and evolutionary dogma. From those great, foundational lies in the modern era is **the superstition of viral contagion.**

However, the people of Tawḥīd who understand the insightful truth spoken by the Messenger (ﷺ) in negation of the superstition of contagion, in negation of the misguided beliefs and behaviours of the Pagan Arabs of Jāhiliyyah, as we have outlined in plenty of previous articles¹—and who recognise the futility of the dogmas of the modern materialists and evolutionists, then such people are remote from such lies, they do not swallow these lies, they do act upon such lies—at least not knowingly and willingly, in the absence of necessity or compulsion.

This is because of the strengthening of their hearts with the soundness of certainty in these affairs due to a combination of

Those who affirm contagion claim that the contagion negated by the Prophet (ﷺ) is the one they ascribed to the Pagan Arabs, that they believed in contagion occurring outside of Allāh’s will and power, outside His decree. However, this assertion is incorrect. It is not known that the Pagan Arabs as a whole used to reject al-Qadar in the first place for them to believe that contagion occurs outside of Allāh’s decree. Nevertheless, they negate contagion upon this understanding while affirming that contagion can take place through mixing by Allāh’s decree. Upon inspection, this view has internal contradictions, and is based upon the very misconception (confusing coincidence with causation) which the Prophet (ﷺ) had removed in the case of the bedouin, his camels and scabies.

sound understanding of legislative realities coupled with sound understanding of creational realities.

As Shaykh Ḥāfiẓ al-Ḥakamī (رَحِمَهُ اللهُ) aptly stated:

The intent is that the negation of contagion is absolute, it is upon its totality and within it is singling out Allāh (سُبْحَانَهُ وَتَعَالَى) with full disposal [of all affairs] in His creation... And within that lies strengthening of the heart of the believers, aiding of them with the strength of reliance and soundness of certainty, and proof for them against the polytheists and all of the stubborn opposers.²

To understand this statement—which may be perplexing to many—one should refer back to the full speech of al-Ḥakamī³, and it is a decisive word in this matter.

He has simply echoed what was said by Abu ‘Ubayd al-Qāsim bin Sallām (d. 224H) over a thousand years earlier and in his speech is a solution to the trial we are undergoing today, the trial of pseudoscience, omens and superstition—he who grasps it grasps it and he who doesn’t, doesn’t.

Thus, our ḥujjāh against the kuffār, mushrikīn and mulḥidīn is:

—**a**) the view of the Salaf on contagion wherein there is only ever the fresh creation of each disease instance in each entity through the mobilisation of all of its causes for that entity at the appointed time and place with a negation of “infectiousness” being the property of any disease and,

—**b**) a falsification of their pseudosciences, in particular, the fraud of Virology which rests upon the fraud of neo-Darwinian

evolution⁴ and which has no place in the modern era and is more suited to the European Dark Ages of superstition and make-believe, alongside the practice of throwing women suspected of being witches into rivers for the “swimming test”.

Minister Hazzard has urged the Sydneysiders to “stay away from other people” to curb the spread of the virus.

⁶ It may be claimed that this is only hyperbole—exaggeration not meant to be taken literally—however, it is being taken literally by millions of people as evidenced by people’s fears and the baseless behaviours built on them. Because of the powerful effect of the imagination on the hearts and minds, the type of language used to personify something invisible, rather, non-existent, can have an adverse, manipulative effect on people’s emotions and behaviours.

“The Delta variant is proving to be **a very formidable foe**,” he said.

“No matter what defensive steps we are taking at the moment, **the virus seems to understand how to counterattack in different locations.**

“This virus is certainly lurking in places we hadn't expected and it is waiting, it is waiting to actually be able to extend it across Sydney.

“We know it can only spread if we're near other people. If we stay away from other people, then that's a major offensive step that hopefully it can't counterattack against.”

COMMENTS

If you have followed this series of articles, you will not need much commentary, but for the sake of revision and reminder, for reminder benefits the believers, we will repeat some of what has been written in past articles in this series:

1. These disbelievers are misinterpreting what are the end-results, or effects (āthār) of the names and attributes of Allāh, among the key ones in this subject matter:

—**al-Muhyī**, the Giver of life and He who brings living out of the dead),

—**al-Mumīt**, the Taker of life and He who brings out the dead from the living,

—**al-Shāfi**, the True Healer,

—**al-Ṭabīb**, the Knower of all causes and effects and routes to things, by which cures and healing is achieved, this being a description, not a name.

These end results and effects are the expulsion of dead, inert, waste material from the body, and they are part and parcel of in-built pre-programmed healing and repair mechanisms. These materials comprise of proteins, genetic debris and fragments, envelopes and the likes.

The misguided “germ theorists”—blindly following a fallacious *one-germ, one-cause one-disease dogma*—combine these elements and abstract them into the notion of a “disease-causing virus”, when no such thing exists.⁷ They frame this from within Darwinian evolution, making it inseparable therefrom.

In effect, what is the end-result of Allāh’s mercy and bounty—fever and its commonly associated symptoms, comprising a purification of sins and also a cleansing of the body for the healthy—is turned into a starting point of materialist, atheist kufr, leading to the type of laughable, outrageous statements that you have just read from Brad Hazzard, such statements that are believed only by simpletons and morons.

2. In the early 20th century, when these spurious, already-disproven doctrines regarding disease and its causes were being shaped and directed for future large-scale commercial interests, **the intelligent and scrupulous physicians** among the non-

However, disease and death does not require a pathogenic virus for it to be explained. So while disease and death cannot be denied, its explanation and true cause is a matter of interpretation based on what ideology you believe in. Most people do not know that the claims of virologists are spurious and that virology is a pseudoscience that relies on trickery and deception. We have discussed this matter in more detail in previous articles in this series.

Muslims recognised what was taking shape and remarked appropriately that **“germs” are just a replacement for the evil spirits, ghosts and witches of centuries bygone.**

But in any case, the bacteria are not the primary cause, but rather the effect, of disease, and in a proper understanding of their true functioning one may lose some of the terrifying effects of the Pasteurian teaching. This aspect of it was very well expressed by Dr. Park L. Myers of Toledo, Ohio, when addressing an assemblage of his colleagues a few years ago: “With all the wonderful strides of our medical science in 100 years, we still have the public as abjectly cowed today before the omnipotent hosts of bacteria as it was by the evil spirits and ghosts and witches of a past century.”⁸

3. This is how, throughout history, the priests and wizards among the kuffār and mushrikīn made fools of their people with the claim of having advanced science and knowledge out of reach of the commoner, using their exclusive monopoly therein to instill baseless, exaggerated fear in them, acquiring their servile obedience and looting the fruits of their private endeavours thereby.

The “pathogenic virus” has become a modern-day technical replacement and revival for those spirits, demons, ghosts, goblins and leprechauns that were feared by the misguided, superstitious ancients and predecessors. It is clothed with the garment of Darwinian evolution—with the Modern Synthesis—of mutation and selection and sold as a predatory invisible enemy from which constant fear and caution is necessary because it “evolves”, “tricks” and “evades”, to use the actual

words of those that express these things in their writings, as if to attribute consciousness and intelligence to dead, inert matter.

4. The health minister claimed that the new “variant” was **“capable of counterattacking health orders”**, that is to say that the virus is a conscious, intelligent entity with the ability to plan and execute. As we have remarked often, do not be deceived and think that these people moved on from the Dark Ages of centuries bygone. No, all that has happened is that they are exactly where they were dogmatically speaking in many areas, save that they have clothed things with layers of sophistication and deception, aided by technology and given it the appearance of science, intelligence and progress.

5. A spurious “test” is being used to brand perfectly healthy people as “cases” or “infectious”—this is the PCR “test”, which is not a test. Its inventor, Kary Mullis (d. 2019 CE), explained that this very sensitive and efficient procedure, not a “test”, simply manufactures and amplifies strands of genetic material. Whatever it picks up cannot give any information about health or sickness and it cannot be used to detect alleged viruses or diagnose “infections” or illnesses.

However, this is the fraud that is being employed to generate “cases”—which are mostly healthy people—and this data is then used to justify lockdowns. When you add the Darwinian “mutants” and “variants” to the fraudulent misuse of the RT-PCR procedure, then you have the perfect tools for making fools of people through pseudopandemics. All of this is the end result of superstition and pseudoscience. Using these tools, you can invent an endless list of “novel viruses” and attribute common symptoms and known

disease conditions to them through the misuse of the RT-PCR procedure. The scene has been set for this to happen in the future, because the world at large has bought the lie.

Pseudopandemics can be created at will, and this is the vision of the future for the Malthusian, Darwinian Eugenicists and Socialists, the Collectivists, who are modern-day Mazdakists—it is the biosecurity state in which the default is that by your mere existence, you are a health threat to the collective, and by breathing out carbon dioxide you are a threat to what they believe is their earth.

6. As for the Muslims, then they do not speak with such speech, attributing intelligence to dead, inert, lifeless matter, treating it as a “superpower” with the ability to trick, evade, adapt and other such statements of make-believe and foolishness, not even as figure of speech or mere hyperbole.

However, due to decades of indoctrination in Western institutions and blindly-following and trusting the disbelievers in particular subject areas without genuine verification—**that is, performing independent scientific experiments to verify and ascertain the very theoretical foundations and premises of these sciences**—they have been negatively influenced to accept much speculation and falsehood lying therein, and this is a systemic problem in the Muslim nation which some people, very sadly, are too closed-minded to acknowledge, because they are puffed up with pride through these sciences they have taken from the people of disbelief.
