BACKGROUND: “THE DEVIL IS HERE”

In previous articles we explained how Allāh (عَزَّوَجَلَّ) has created the body with **self-healing capabilities** and that “colds” and “flus” are **repair mechanisms** that are triggered by internal and external factors.

They are necessary and beneficial and for healthy people they lead to some days of discomfort. These programs are **biologically meaningful and purposeful**.

Toxins, built-up waste, dead cells are expelled and **enervation** is released from the body through them. **Bacteria** (**waste recyclers and manufacturers**) and what are incorrectly called “**viruses**” (**communications messengers and transporters**) are involved in certain processes, but they are not primary causes of disease. They are a consequence of a disease state, and are

released from the body, once they have been utilised, along with the toxins, waste materials, damaged cells and linings whose removal they were involved in.

The atheists, materialists and Darwinian evolutionists have constructed an incorrect model of disease upon the principles of their disbelief, upon their rejection of Allāh’s rubūbiyyah.

They present the “virus”—which they have mislabelled and grossly misunderstood—as if it is a **living, conscious agent**, that is able to “**trick and evade**” and acquires **superpowers**, through **the process of Darwinian evolution**.

These are tales which they have clothed in scientific language, but there is no truth to them, and these tales are only believed by the ignorant and ill-informed.

1. Previously in this series we explained that during the early 20th century, **the commercially minded germ theorists** were pushing the idea that **the body is sterile**¹ and that **each disease** is tied to **one microbe** in **a one to one causal relationship** and that these “germs” come from the outside, to invade, seeking to replicate and survive, from a Darwinian evolutionary perspective. Upon this idea, they claimed that their serums or injections prevent the disease or reduce its severity.

Fear was the central driver for their merchandise, because it is known that fear suspends rational thought.

These people:

—a) dismissed the multifactorial nature of disease,

¹ Meaning that there are no “germs” or microbes, such as bacteria or “viruses”, in the body, and it is internally “clean” and “pure”, and that these “germs” come from outside and are **the primary agents** of disease. Although bacteria and what are wrongly labelled as “viruses” are involved in processes that produce what we observe as outward symptoms of disease, they are not root, primary causes of the disease itself.

—b) took away responsibility for one’s health from individuals,
—c) portrayed as if health, cure and well-being can only exist in an injection,

—d) concealed the fact diseases like smallpox, leprosy, pertussis, measles and others, declined because of social reforms, because of better living conditions, access to clean water, sewage systems, better nutrition and better planning of towns and cities. When these reforms were made, these diseases began to decline and they were no longer fatal, except in the severely malnourished.

They hid these realities and claimed that their serums and injections caused the decline. This is not true, but they covered up and rewrote history with propaganda and lies.

This is all established and documented in the history books and in the historical records and is very easily discovered by the one who bothers to research into the matter.

Those who helped to lay down the foundations for this inaccurate model of disease and medicine were **Frenchman Louis Pasteur** and **German Robert Koch**.

Both were fraudsters and conmen who falsified their research and used lies and deception therein and they paved the way for the vaccine companies of the 20th century to operate in pretty much the same way. It is for no strange reason that these companies—including Pfizer, GlaxoSmithKline and others—have been regularly fined, sometimes in billions, if not hundreds of millions of dollars for fraudulent, criminal activity.

2. There was an ongoing battle between the “germ theorists”, conmen like Pasteur, Koch, their ideological and financial backers and their followers and those who had proven these ideas to be false such as **Claude Bernard, Antoine Bechamp** and others. These were the men who gave a truer picture about the nature of disease and its processes, and they were genuine, honest, scrupulous scientists.

However, it was the germ theorists who dominated because of the financial power behind them and their ideas. The money-power seeks to exploit whatever idea is the most profitable.

To help the reader understand more clearly and appreciate this point, the Mu‘tazilah acquired power in the 2nd century hijrah and used it to impose their religious doctrine upon people in a forceful manner, even though this was short-lived.

The Ash‘arites in the 6th and 7th centuries managed to spread their doctrines through schools and institutions they set up in various lands, until many generations of scholars were produced who thought that this was the truth, and this has continued till this day.

The incorrect principles of groups such as the Ash‘arites remain today, being taught in universities, printed in books, and found in the minds of millions of Muslims. But this is not evidence that their principles are sound and correct.

The same thing can happen and has happened in the worldly sciences. This is an obvious matter recognised by any intelligent person. And this is why the study of the history is very important, as long as it is an objective, unbiased study of history.

We do not rely on the books of the Mu‘tazilah alone and nor those of the Ash‘arīs alone in our study of history. Otherwise we

will be told a history in which Wāṣil bin ‘Āṭā and ‘Amr bin ‘Ubayd and al-Qāḍī ‘Abd al-Jabbār are the Shaykhs and champions of Islām, or that Abū Maṣṣūr al-Māturīdī, or al-Rāzī and others are the Shaykhs and saviours of Islām, and that their principles are sound principles from which creed is derived.

The same thing applies to worldly sciences, including medicine.

We have only been given the incorrect Pasteurian model that was founded upon fraud and deception and a gross misunderstanding of microbes, and later, of what are wrongly called “viruses”. Pasteur is presented as a hero, rather than the calculated conman and fameseeker that he was. And the textbooks are written on this basis, to promote this narrow, inaccurate model of disease.

3. Over the last 100 years, those following Louis Pasteur and Robert Koch in their fanaticism against “germs”—**the vaccine producers**—have gained tremendous financial and political power. They have managed to create **a sophisticated technical infrastructure** which allows them to stoke fear—upon this false, inaccurate theory of disease—in order to sell their injections while concealing and dismissing the true causes of diseases, which are multifactorial in nature.

4. Coming to the subject of this article, in Part 5 of this series, we mentioned how the intelligent physicians and scientists of the time in the early 20th century knew what was taking shape and how this false, inaccurate theory of disease was being used as a tool for manipulation and to install a future large-scale commercial enterprise, not as genuine medicine with a holistic approach to matters of health and disease.

These physicians saw that “germs” were becoming a modern day revival of the **demons, spirits, ghosts and witches** that people feared in previous centuries:

But in any case, the bacteria are not the primary cause, but rather the effect, of disease, and in a proper understanding of their true functioning one may lose some of the terrifying effects of the Pasteurian teaching. This aspect of it was very well expressed by Dr. Park L. Myers of Toledo, Ohio, when addressing an assemblage of his colleagues a few years ago: **“With all the wonderful strides of our medical science in 100 years, we still have the public as abjectly cowed today before the omnipotent hosts of bacteria as it was by the evil spirits and ghosts and witches of a past century.”**²

In light of the above, here we are, **almost exactly 100 years later**, and what do we see in the headlines?

We see that the “virus” has now become the devil and the devil has become a virus.

Thus, what we saw in the headlines and reports in previous articles in this series, that the virus:

—has developed

superpowers

—is able to **trick** and **evade**

—is “**mutating**” due to **evolutionary pressures**, becoming more and more evil and dangerous

The virus has gone beyond all of that and has now become the devil himself.

All of this falsehood has arisen because of the misguidance of the disbelievers in the matter of viruses, evolution and the nature and reality of disease and its processes.

5. As we explained previously, what is being detected as a “virus” is nothing but small genetic fragments, debris, broken down waste material that is being expelled **through meaningful biological programs** that we call “colds” or “flus” (ḥummā, zukām). These are in-built into the body by Allāh (عَزَّوَجَلَّ).

There is no such thing as a whole, intact, “infectious” virus in any sample. No such thing has been isolated, purified, in the proper sense of these words, directly from a sample and then observed under a microscope.



All that is happening is that they are taking **this completely, dead, inert genetic material**, along with whatever **proteins** are in these samples and then **defining a virus** into existence.

Depending on what sequences they find, they create families and categories of viruses—such as influenza A, B, adenovirus, coronavirus, pneumovirus and so on—and claim that they are the causes of disease, when in reality, they are **the end-products**, the waste-products of disease and its processes in returning the body to normality.

The full genomic sequences they come up with from the various fragments **are theoretical and not actual**.

They are arbitrarily patched together, using guesswork and the use of computer software and then it is uploaded to a genetic bank, a database. Everybody thinks that this the actual genome of an alleged “virus”, when it is nothing of the sort.

Then, upon their Darwinian evolutionary doctrine, they claim that this theoretical virus is mutating and that variants are developing. In reality, these variations are just the natural variations in the genetic fragments that are being expelled from the body /or they are an artefact, a by-product of the technique used to detect them, which is the PCR procedure.

6. Upon this, it is possible to devise PCR “tests” that identify and amplify a particular genetic sequence of choice. This can be used **to invent a new virus or a variant at will and likewise, a new disease label at any time**.

Existing and known disease conditions, such as the regular cold and flu can then be **recategorised** into this new disease through the use of these dubious tests, and it becomes easy to **generate fake pandemics** driven entirely by testing and the use of symptoms common to so many illnesses.

What people routinely and normally die of—the various chronic illnesses like flu, pneumonia, cancer, diabetes, heart disease, dementia and so on—they can be relabelled and recategorised as deaths from the new disease through this test, if a person tests positive for that chosen genetic fragment.

In reality, there is no causal relation or no evidence of any causal relation between the detected genetic fragment and whatever symptoms are present.

This is admitted and stated explicitly by the FDA, by test manufacturers even, and we have cited their statements previously. They say that these tests **should not be used for diagnosis** and are for research purposes only, and that whatever is detected, it is not evidence that it is the causative agent of the disease. Despite this, these PCR “tests” are being used everywhere.

Given that these types of “tests” can never be used on their own for diagnosis of an illness, they can be misused to create fake epidemics, to invent “cases” out of perfectly healthy people and create the false category of “**asymptomatic carrier**”, of which there is no such thing, or evidence of such a thing.

This was an invention of germ theorists and vaccine manufactures to help expand their vaccine markets and to subject entire populations to their injections.

7. This is why the **one to one monocausal relationship** between a “germ” and a disease is very lucrative and profitable. You can endlessly invent viruses and their alleged mutations. With billions of people on the earth, the market becomes huge.

The infrastructure for achieving this has been put in place by people like Bill Gates and his backers and associates, and they have turned this into **a future trillion dollar annual market** for

what are in reality **gene-therapy products** and not traditional vaccines. These products are deceptively labelled as “vaccines” for the purposes of securing legal indemnity and protection.

What was happening in the early 20th century, in the 1920s, on a small scale, has now become a worldwide enterprise, with a sophisticated technology infrastructure coming into shape that treats every person as “infectious” by default.

Upon this, people’s social and economic activity can be determined and restricted by their “infection” status.

It is very easy to scare and control people by claiming that there is **a constant evolutionary threat** from “viruses” which continue to evolve and mutate because of “**evolutionary pressures**”, acquiring more and more **superpowers and abilities**. This being an ongoing affair of Darwinian evolution.

The “virus” has now turned into a devil as a means of scaring people even further.

It is not possible for such outrageous things to be said and for such ideas to develop except from the minds and mouths of those who wander blindly in their misguidance, exulting in their speculative sciences.

8. As for those who say that the “virus” is “a soldier among the soldiers of Allāh” and “from His signs” and speech similar to this, then this is the saying of those who are ill-informed and who have been deceived and misled by pseudoscience.

They are simply trying to merge the unproven speculations of the disbelievers within a Darwinian evolutionary framework, with Allāh’s rubūbiyyah, and the two do not mix and cannot be reconciled. Those who say these types of things do not know the reality of what they are saying. This is similar to those who try to merge the speculative **Big Bang model of the universe** or

Einsteins’ Relativity with the Qur’ān, they do not understand the reality of what they are saying because they do not know the realities of these speculative ideas and why and how they came about and what ideological purposes they serve.

These affairs—including the germ theory model of disease within **the Darwinian evolutionary framework** through which they are being presented to us—undermine Allāh’s rubūbiyyah and support the causes of the disbelievers.

9. The final word, once again, must go to Shaykh Ḥāfiẓ al-Ḥakamī (رحمته الله) for there are no words more appropriate than these:

The intent is that the negation of contagion is absolute, it is upon its totality and within it is singling out Allāh (سُبْحَانَهُ وَتَعَالَى) with full disposal [of all affairs] in His creation... And within that lies strengthening of the heart of the believers, aiding of them with the strength of reliance and soundness of certainty, and proof for them against the polytheists and all of the stubborn opposers.³
