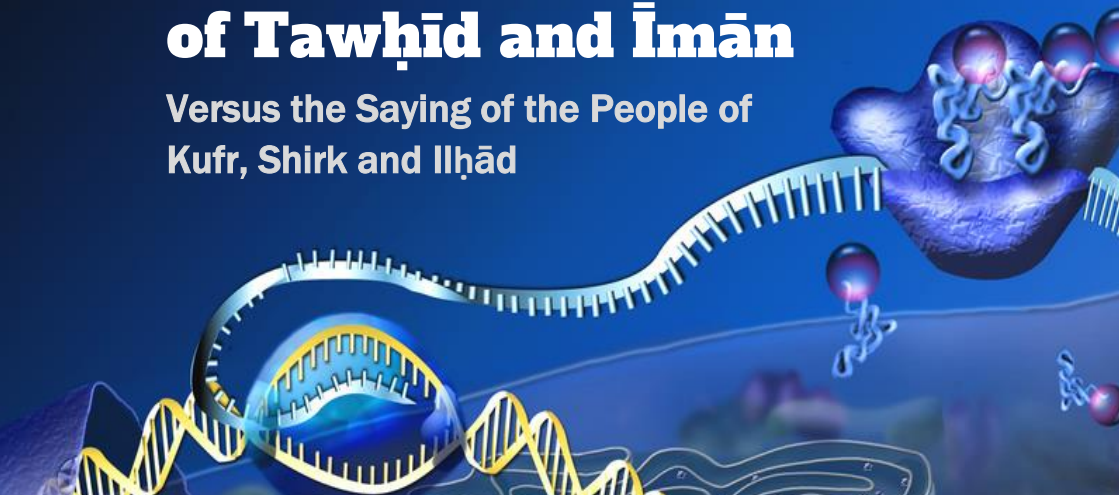

## Introduction

**Shaykh ‘Abd al-Raḥmān bin Nāṣir al-Sa’dī (رحمهُ اللهُ)** said:<sup>1</sup>

Ideas and sciences alone without a heart that pursues goodness and truth is not sufficient by itself. Rather, their harm can be plentiful due to them being devoid of īmān, being devoid of sound guidance, and due to the people [of these sciences] being arrogant on account of them...

For their rejection of Allāh’s signs and their arrogance towards them, their mockery of them and belittlement of the people [who affirm and believe them] necessitated the absence of them benefitting from their [faculties of] hearing, sight and thought, reflection. This has never ceased to be their way until punishment became justified upon them.

So look at their sciences which were not founded upon īmān, rather they were crass, deviated sciences which became a reason for them to oppose the Messengers and for them to remain upon what they are of disbelief and rejecting the truth, so we seek refuge in Allāh from knowledge that does not benefit.

The Darwinian Atheists and Materialists in their rejection of a Creator claim that life arose on its own in an undirected

manner through random physicochemical interactions. They have three speculative routes in this respect:

- That “**viruses**”<sup>2</sup> came first (RNA viruses),
- That **proteins** came first, or
- That **metabolism** came first.

The first, regarding “viruses”, is one of their major theories. Through it comes their explanation of “viruses” as **major drivers of evolution** through **mutation and selection** leading to **variants** that become “fitter” and “stronger”, while driving novelty and adaptation in organisms. This naturally enters into their explanation of disease and how disease is itself an ongoing driver of evolution.

The virus struggles to survive and replicate, and in the process, it drives its host to also adapt and evolve, just like itself, thus disease drives evolution:

Coronavirus, Zika, Ebola, flu, even the boring old common cold – we’re all familiar with the viruses that plague humanity. But while we know they make us sick, it may be surprising to discover that, over millions of years, we’ve managed to harness and domesticate these crafty invaders.<sup>3</sup>

It is necessary for Muslims to beware of the false and speculative nature of these ideas and theories despite them

being presented as “scientific”. This is because they have a direct impact on matters of Tawhīd and Īmān and also on people’s thoughts and behaviours.

What has been mistaken and misrepresented as a “virus”<sup>4</sup> is nothing but a combination of:

—**a) breakdown cellular and genetic material** from dead and morbid cells that have undergone dissolution and the resultant material prepared for excretion and elimination which includes accumulated toxins and synthetic molecules.

—**b) microvesicles** that serve as messenger or transporter vehicles for communication or load transfer, these vesicles can also enclose the contents of dead cells released into the intercellular space .

—**c) enzymatic or other types of proteins** generated and released by the body to aid in the breakdown and elimination of unwanted, accumulated dead tissues and cells. Consider these as internal “soaps” or “detergents”. And likewise, other proteins which are logistical in nature.<sup>5</sup>

What are referred to as “colds” and “flus” are **detoxification, healing, regeneration and repair programs** which are pre-programmed into the body by its Creator and Maker. Damaged tissues, cells and linings are broken down and accumulated waste, morbid material and toxins are eliminated

through these programs, while underneath, behind the scenes, the body regenerates new tissue, cells and linings. **Fever** is the main underlying driving mechanism and the process of elimination is facilitated through other things like **coughing, sneezing, runny nose, diarrhea, sweating** and so on.<sup>6</sup>

There are **biological meanings** in all of these things which cannot be separated from Allāh's Names and Attributes. The Materialists have stripped all biological meanings, purposes, end-goals and wisdoms and reconstructed what they think is happening upon the principle of their materialist pseudoscience. Fundamental to all of that is Darwinian evolution which they have made inseparable from the biological sciences.

This leads to various conceptualisations and theorisations within these sciences and the subsequent impregnation of meanings derived therefrom into words such as “virus”.

A Muslim may use these words while being unaware of the reality of what they are being used for and the dubious or errant concepts they hold and convey.

The reader is advised to return to and reflect upon the statement of Imām al-Sa'dī cited above.

In the Prophetic Sunnah, fever is a blessing, it purifies a person in two ways, purification from sin (as expiation) and cleansing and revitalisation of the body. And likewise, sneezing

is a blessing from Allāh, **it is not a disease**, a curse or an omen as the Pagan Arabs used to believe.<sup>7</sup>

So within this context, if a Muslim believes that there is a “virus” which comes from a sick person, meaning what he expels during his sickness, like a cold or a flu and he is labelling what is expelled of **cellular breakdown materials, genetic material, microvesicles** and **detox proteins**—[along with the original toxins which may have accumulated in the body and which may have, along with other factors, given rise to the triggering of the cold and flu program in the first place]—as a “virus”, *in its original Latin meaning* of “**noxious fluid**”, then there is no issue with this.

It is just a misinterpretation made by the germ theorists who have confused effect with cause, after incorrectly labelling what they are picking up and detecting as a “virus”.<sup>8</sup>

Upon this notion, he can keep away from a sick person if he believes that this might make him sick, even though no evidence has ever been established that colds or flus are “infectious” and real life experiments have failed to demonstrate this.<sup>9</sup>

Hence, if a Muslim was to believe that a sick person expels a “virus”—**upon this simple meaning**—this person has not fallen into any Darwinian concept or trap. Its just a matter of

mistaking an effect or consequence with a cause and an incorrect, dubious label being used.

This is just a matter of a Muslim keeping away from a sick person to avoid harm and exposure to morbid materials, waste products or toxic materials which he believes may make him sick, similar to how he avoids exposure to toxic metals, chemicals and compounds.

However there is **a post-1950s concept** of the “pathogenic virus” tied to the “Modern Synthesis”<sup>10</sup> of Darwinian evolution, where the “virus” is now presented, through lies, deception, pseudoscience and fraud, as **a semi-living invader, hijacker and replicator**. This is where the danger lies, because inherently and implicitly, one has to then accept the foundation of mutation and natural selection as it is inseparable from this conceptualisation of the alleged “virus”. Disease is then framed from this perspective, as a necessary part of evolutionary progress.<sup>11</sup>

Upon that, outbreaks of illnesses such as influenza are considered ongoing validations of Darwinian evolution before our very eyes and thus, when you mistake what is dead, inert, cellular breakdown materials including genetic fragments and proteins as a “virus” in this sense, the “Darwinian virus” sense, then this is where problems lie, and it can have an impact on beliefs, thoughts and behaviour. Since it is a falsification of

reality and a lie in Allāh’s Rubūbiyyah, a distortion of what He created, then this will lead to thoughts and behaviours that go beyond the bounds.

Danger lies here for Muslims because all of these claims regarding the alleged pathogenic Darwinian virus are false and can be shown to be built upon Darwinian materialist pseudoscience, misinterpretations, deception, sleight of hand trickery in laboratories, playing with words and definitions, the use of maths and models to conjure up a fake reality, and outright fraud in the very foundational principles and methods of scientific research itself.<sup>12</sup>

Further, if a Muslim says about this particular “Darwinian virus” that it is Allāh who created it and whatever happens is through Allāh’s decree, it is similar to the saying of those Muslims who have accepted that man came through processes of Darwinian evolution and then say, “That’s how Allāh did it, I ascribe it to Allāh.” So while they return it to Allāh and His decree, this does not make it true just because you add the phrase “It happens like this through Allāh’s decree.” It means you are validating the mechanism (mutation and selection)—[the ṭaghūt of the “Modern Synthesis”<sup>13</sup> which the disbelievers made a foundation for their kufr in the 20<sup>th</sup> century]—but without really being aware of this.<sup>14</sup>

And if you say, “I deny that it is Darwinian” or “I deny that there is any so-called neo-Darwinian ‘mutation and natural selection’”, then simply say “I believe it is inert, dead, waste, genetic and proteinacious material expelled from the body in an intelligent, coordinated, pre-programmed way” and the matter ends there.

**This is because the modern-day conception of the virus is completely and wholly Darwinian in nature.**

So this is where the danger lies for Muslims and it is necessary for this to be pointed out. Otherwise, we can be drawn into beliefs, thoughts, statements and behaviours that are erroneous and can start to undermine Tawhīd and Īmān.

Everything called a “virus” or being “viral” is nothing more than genetic or protein material from **human cells, mitochondria, bacteria, fungi** and **archaea**.

The theoretical genetic sequences that are invented/fabricated out of this **composite genetic material** through the use of computer software has no correlation to physical reality, it is wholly a fraudulent enterprise.

The notion of an “external pathogenic virus” is merely abstracted into existence and no genuine scientific evidence is ever provided for this claim.

I present just a small sample out of an abundance of citations to highlight what has been said so far

which He has placed in the body, a manifestation of His Rubūbiyyah—and turning them into starting points for their Darwinian evolutionary theories.

# 1. Viruses, Evolution And Immunity

First we quote the general conception of the post-1950s “Darwinian virus” from a paper: “**What viruses tell us about evolution and immunity: beyond Darwin?**”<sup>15</sup> which shows it is inseparable from Darwinian evolution.

We describe mechanisms of genetic innovation mediated by viruses and related elements that, during evolution, caused major genetic changes beyond what was anticipated by Charles Darwin. Viruses and related elements introduced genetic information and have shaped the genomes and immune systems of all cellular life forms. None of these mechanisms contradict Darwin’s theory of evolution but extend it by means of sequence information<sup>16</sup> that has recently become available. Not only do small increments of genetic information contribute to evolution, but also do major events such as infection by viruses or bacteria<sup>17</sup>, which

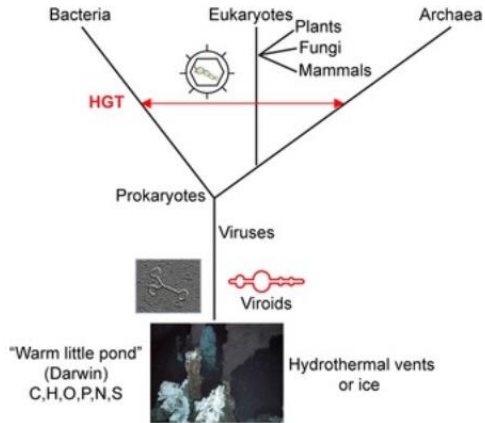
<sup>16</sup> Since it is nothing but human and animal genetic material combined that is being used to manufacture the so-called genomic sequences of the alleged “virus”, the sequences have no physical reality to them and are simply theoretical, speculative, mathematical and artistic fabrications through the use of computer software. This allows the creation of genomic databases and all subsequent research is done via models, not via interaction with physical reality. Thus when “variants” are spoken of, they are speaking only of a model they have on computer, and not about anything that exists in physical reality. In this way, endless variants can be generated and used to deceive and instill baseless fear into people.

Their true role and purpose has been

can supply new genetic information to a host by horizontal gene transfer. Thereby, viruses and virus-like elements act as major drivers of evolution.

**Diagram:** The picture shows what they call viroids and viruses as the first thing to emerge out of Darwin’s “warm little pond” from which all other life forms allegedly evolved.

So we are not talking about a “toxin” or “poison” as such but a fundamental Darwinian entity that shapes genomes and “immune systems” of all cellular life forms in ways that extend Darwinian theory. As such “infection by viruses” is a major driver of evolution.



As already stated, someone can say: “I believe this is by Allāh’s decree”, but this would be similar to responding to the claim that the first man came through Darwinian evolutionary processes by saying, “Allāh created Ādam through this process”, as in, that is the mechanism which He used, which is “mutation and selection”. And if someone says: “Allāh created the ‘virus’ but it has nothing to do with Darwinian processes”, then in that case just say it’s a mere toxin/noxious element or detox protein being eliminated from the body, something dead, inert and nothing more, it does not “invade”, “hijack”,

misunderstood due to a flawed model of disease and this is another arena of error and misunderstandings found with the germ-theorists.



“replicate”<sup>18</sup> and all the other lies that follow. But the moment you start speaking of this semi-living ‘virus’ invading, hijacking, replicating and so on, you’ve entered into the Darwinian conception which is false, has no basis and is a gross misinterpretation of observations made by the materialists.

Likewise, the moment you accept “variants” and “mutants”, then you have also accepted the Darwinian conception of the virus, which is imaginary.

Thus, we can see the entanglement that follows if we accept this post-1950s conception of a virus and this is what we are clarifying and whose danger we are pointing out, making clear the difference between what is said by the people of Tawhīd and Īmān with respect to creation, health and disease—upon Allāh’s Rubūbiyyah and His Names and Attributes—and what is said by the people of Kufr, Shirk and Ilhād as embodied in the concept of the Darwinian virus, which is their central driving force for evolution as a whole, they see what they label as “RNA viruses” as the starting point, and this is pure conjecture and make-believe.

When they say, “viral replication”, this just means cells are dying and breaking down for reasons other than an imaginary “pathogenic virus”, and which return to insufficient nutrition, build up of toxicity through toxins, synthetic drugs and molecules and in the modern age, exposures of various types, such as harmful gases, particulate matter and EMF radiation and so on. And when they say, “viral load”, they just mean the amount of dead, morbid materials being produced in the organ in question, such as the lungs or liver and which the body is eliminating through means and mechanisms that Allāh has preprogrammed into it. Similarly, “viral clearance”, or “viral shedding”, it just means the body is eliminating dead, morbid materials. In all of this the “Darwinian virus” is purely theoretical and imaginary, it has been abstracted into existence on the basis of an incorrect and flawed theory of disease.

With the disbelievers it is all framed as war, battle, struggle between viruses and humans from a Darwinian perspective, in which over millions of years, humans developed “immune systems”<sup>19</sup> to combat viruses and viruses developed strategies in turn, as they say, and all of this is false.

This is not how Allāh’s creation works, and unfortunately, Muslims have been influenced by these materialist theories and sciences.

However, this is not how things really work. The true model is that Allāh created all biological life upon balance, homeostasis, equilibrium of all systems, and when there is deviation or departure from that balance [brought about through sin and thereafter violations in human conduct, in diet, habit and lifestyle], then Allāh has placed corrective, healing, repair, normalisation programs which manifest as acute (short term) illnesses in which homeostatic correction is sought. From them are fevers, colds, flus, poxes and so on. These are an expiation for sins and also a cleansing of the body, a mercy and bounty from Allāh. And then within these programs, bacteria and various other elements and components (which are labelled as “viruses” by germ theorists) are consequential and play a role in the program. They are not primary causative agents of disease as claimed by the germ theorists within a Darwinian context. The germ theory of disease was already falsified in the early 20<sup>th</sup> century, just as “Virology” has been exposed as a fraud in the late 20<sup>th</sup> and early 21<sup>st</sup> century in courts of law in addition to laboratories.

## 2. The Darwinian Pandemic Virus

The next statement is from an article on a website for doctors (GPs in the UK), and this is what is promoted to tens of thousands of doctors, among whom are a significant number of Muslims, about the so-called “**Darwinian Virus**”, and this is the standard line of thinking in modern science:

Professor John Oxford reflects on how this Darwinian virus<sup>20</sup> came to dominate the 2010/11 flu season.

We have just been visited by the third wave of a classical super fit, dominant and very Darwinian pandemic virus. In fact Charles Darwin would find it incredible to view his own theory of survival of the fittest proved before his very eyes in one year.<sup>21</sup>

The disbelievers speak like this because the very conception of the “virus” is intrinsically Darwinian in nature, from its beginning to its end and cannot be separated from it. Thus,

every epidemic or pandemic or individual illness is framed from the angle of an evolutionary agent that invades, hijacks, replicates, struggles, mutates adapts, spreads and survives, using the vulnerabilities of haphazardly created biological life and contributes, in a small or large way, to the evolutionary process as a whole.

And as we shall see, this leads to the claim that a scientific approach to dealing with pandemics is therefore not possible except upon the foundations of Darwinian evolution.

And this is what we see today among the disbelievers when they speak of viruses mutating and so on, leading to variants, and all of this turning into a so-called biological “arms race” between viruses and human, this becoming a narrative in itself used to influence and control the behaviour of people.

Thus, a new virus appears through mutation and selection, so an alleged “vaccine” is produced against, it, but the virus mutates and outwits the whole world, and then the race is on for another “vaccine” and then this process continues. So this is an ongoing “arms race” as they claim, between “variants” and all of mankind.

Mankind itself, in this ongoing battle against the Darwinian virus, is very kindly and generously represented by the giant pharmaceuticals corporations—backed by great philanthropic contribution from Bill Gates and the Malthusians and Eugenicists—and they work tirelessly against the “virus”.

Its very dramatic and theatrical, great for manipulating people through fear for business and profits, but completely false and baseless.

It is all pure speculation based on misinterpretation of observations along with scientific fraud. The deception has

been compounded in the late 20<sup>th</sup> century through the use of genetic sequencing to maintain the illusion, but this discussion is for another place. In short, all alleged “genomes” for alleged “viruses” and their “variants” or “mutants” are nothing but theoretical, mathematically generated sequences with the use of computer software for gap-filling and creative construction.

Since the disbelievers are misinterpreting the body’s own genetic breakdown material or proteins that it generates as “viral” in origin<sup>22</sup> and then theorising and abstracting these components into a foreign semi-living entity capable of being

Then they began to speak of “endogenous retroviruses” (ERVs), those that come from within the body, and “exogenous retroviruses” (XRVs), those that come from outside, and this is what they claim are disease causing agents. They have no evidence for this except misinterpretations, not realising that what they are picking up are consequences and effects of an illness, not its cause, similar to how someone wrongly thinks firemen and charcoaled remains and ash were the cause of the fire just because they are found at the scene of the fire, whereas the fire was caused by something else. So what they are picking up and detecting is waste, broken-down cell debris, genetic fragments and proteins, which are the end points and end products of biologically meaningful processes (acute illness) and they turn them into the starting point and foundation for their materialist theories. Thus, when they detect different genomic sequences from a patient sample and categorise them into say: Influenza A, Influenza B, Adenovirus, Pneumovirus, Coronavirus and so on, all they are doing is detecting and sequencing something that the body itself produced, such as certain proteins, mixed with all the debris, genetic fragments and so on. However, they also mix what they think is the “virus” containing sample with animal tissues when they attempt to culture and grow more of the alleged “virus”. So what they really have is a mixture of human and animal genetic material out of which they fabricate, through the use of computer software, a genome sequence having no physical reality whatsoever.

transmitted, it is possible to turn perfectly healthy people as “infected” and as “carriers”—such as what is said today, “asymptomatic carriers” on account of dubious “tests” that do nothing except detect a person’s own genetic information. Thus, you are only testing “positive” for your own genetic material in reality.

This allows the door to become wide open for baseless, exaggerated fear, superstition and omens.

### 3. Viruses As Key Drivers Of Evolution

The affair could not have been stated more clearly than what occurs in the following article from ScienceDaily.Com, “**Viruses revealed to be a major driver of human evolution**”.<sup>23</sup>

The constant battle between pathogens and their hosts has long been recognized as a key driver of evolution, but until now scientists have not had the tools to look at these patterns globally across species and genomes. In a new study, researchers apply big-data analysis to reveal the full extent of viruses’ impact on the evolution of humans and other mammals.

Their findings suggest an astonishing 30 percent of all protein adaptations since humans’ divergence with chimpanzees have been driven by viruses.

“When you have a pandemic or an epidemic at some point in evolution, the population that is targeted by the virus either adapts, or goes extinct. We knew that, but what really surprised us is the strength and clarity of the pattern we found,” said David Enard, Ph.D., a postdoctoral fellow at Stanford University and the study’s first author. “This is the first time that viruses have been shown to have such a strong impact on adaptation.”

The study was recently published in the journal eLife and will be presented at The Allied Genetics Conference, a meeting hosted by the Genetics Society of America, on July 14.

“We’re all interested in how it is that we and other organisms have evolved, and in the pressures that made us what we are,” said Petrov. “The discovery that this constant battle with viruses has shaped us in every aspect -- not just the few proteins that fight infections, but everything -- is profound. All organisms have been living with viruses for billions of years; this work shows that those interactions have affected every part of the cell.”

Viruses hijack nearly every function of a host organism’s cells in order to replicate and spread, so it makes sense that they would drive the evolution of the cellular machinery to a greater extent than other evolutionary pressures such as predation or environmental conditions. The study sheds light on some longstanding biological mysteries, such as why closely-related species have evolved different machinery to perform identical cellular functions, like DNA replication or the production of membranes. Researchers previously did not know what evolutionary force could have caused such changes. “This paper is the first with data that is large enough and clean enough to explain a lot of these puzzles in one fell swoop,” said Petrov.

The team is now using the findings to dig deeper into past viral epidemics, hoping for insights to help fight disease today. For example, HIV-like viruses have swept through the populations of our ancestors as well as other animal species at multiple points throughout evolutionary history. Looking at the effects of such viruses on specific populations could



yield a new understanding of our constant war with viruses -- and how we might win the next big battle.

As explained in the introduction, the Darwinian Atheists have stripped the creation from having a Creator and upon their materialist doctrine constructed a false version of physical reality that is heavily impregnated with the subtleties of their kufr. They have removed the true biological meanings of things—because everything is now divorced from Allāh’s names and attributes—and replaced them instead with the necessities of their disbelief. They have turned what are the **end-points of Allāh’s mercy and wisdom**—waste, morbid materials expelled by the body for biologically meaningful purposes, through pre-programmed healing and repair mechanisms within a purposefully designed and created biological organism—into the starting point for their evolutionary fairy tales.

The imaginary, theoretical “Darwinian virus” —having no physical reality and existing only in silico (on computer)—is presented as the fundamental and most important particle within this evolutionary dogma. ## 4. Pakistani Atheist: Our Debt To Darwin

Next, we have an outspoken Pakistani atheist, Pervez Hoodbhoy who openly calls to his atheism and derides religion—he writes for the Wire magazine:

### **The New Coronavirus Has Reminded Us of Our Debt to Darwin**

Pervez Hoodbhoy—11 April 2020

Charles Darwin is a name Pakistanis are taught to hate. School teachers and university professors tasked with teaching his evolutionary theory usually skip the subject or, if they go ahead, first soften it with a ton of scorn. A commonly used biology school textbook rubbishes the theory, claiming that evolution of species is tantamount to assuming that “a motor car is evolved” when two rickshaws collide. Imran Khan, in his 2002 article, blamed the West’s follies upon “philosophers like Darwin, who with his half-baked theory of evolution had supposedly disproved the creation of men and hence religion, were read and revered”.

With the coronavirus apocalypse looming ahead, it doesn’t matter that Darwin was a naturalist, biologist and geologist rather than philosopher. It also doesn’t matter that Darwin gets lashed regularly by Christian, Jewish and Hindu fundamentalists as well. Yet every hope for dealing with today’s rogue virus rests squarely upon Darwin’s 200-year-old discovery of the principle of natural selection.

In a nutshell, natural selection says that life on Earth didn’t come pre-purposed and pre-formed, as tradition insists. Instead, it holds that, whether for man or microbe, only those forms of life best adapted to a specific environment survive while all others die away. Most crucially, evolution maintains that new kinds of life and new molecules randomly appear. A few – like the coronavirus – will chance upon some suitable animal or human cell and thrive.

Darwinian selection is as fundamental to biology as Newton’s laws are to physics... not teaching evolutionary theory won’t stop brand new forms of viruses from emerging. But then forget about any scientific approach to diseases and epidemics.<sup>25</sup>

So essentially he is saying that a scientific approach to diseases and epidemics is not possible except through Darwinian evolution and selection—[which holds that “life on Earth didn’t come pre-purposed and pre-formed, as tradition insists”]— because it is fundamental to biology.

And what is that scientific approach?

It lies in attempts to keep up with the virus by upgrading the body via “self directed evolution”. In other words teaching what is to them a haphazardly created, imperfect, vulnerable body to recognize and counter the Darwinian virus. Everything is focused on this alleged virus, exclusive to all the other genuine causes of disease, dismissing the fact that disease is multi-causal, multi-factorial. So we also add another error here, which is exaggeration in the properties of an assumed, imaginary entity, the Darwinian virus, which is now treated as the sole agent of disease and death exclusive to other causes and factors.

And when you exaggerate in this one alleged cause<sup>26</sup>, and there is also an ideological and philosophical baggage attached to it, it can lead to errors in human behavioural conduct, such

conduct that the perfect and complete guidance of the Messenger (ﷺ) came to put an end to.

He says at the end of his article:

Thanks to biological science – the foundation of which was laid by Charles Darwin – the coronavirus will eventually turn out to be a deadly but controllable affair... All beneficiaries of modern medicine should surely forgive Darwin for his supposed transgressions.

As we have explained before, Darwinian evolution has been infused into all the biological sciences, it is the foundation of it all and this is how the disbelievers have structured their materialist sciences. Thus, what can happen is that the meanings and observed purposes, goals and wisdoms in things, in created entities, processes and cause-effect mechanisms which are tied to Allāh's Names and Attributes, they are undermined and stripped, and we are left exposed to what the Materialists and Atheists have reconstructed of their misinterpretation of creational reality upon the principles of their disbelief and shirk.

As for Hoodbhoy's statement: "All beneficiaries of modern medicine should surely forgive Darwin for his supposed transgressions", what he means is that all religious people should take back their attacks on Darwin for transgressing against their religion with his theory, because they are beneficiaries of modern medicine that is founded upon and derived from his theory, it being the foundation for their biological sciences. This point will be made also, with further derision, by another atheist and hater of religion, a Bangladeshi by the name of Taslima Nasreen who is quoted later.

## 5. The Evolutionary Arms Race

Then we have this piece in the Proceedings of the National Academy of Sciences titled “**The Pandemic Exposes Human Nature: 10 Evolutionary Insights**”.<sup>27</sup>

“Nothing in biology makes sense except in the light of evolution”(1), and nothing about the human response to COVID-19 will either.

The evolutionary arms race between humans and viruses has existed for millennia. Our bodies, packed with nutrients and the machinery of cellular reproduction, are irresistible targets for exploitation by smaller and faster-evolving organisms (2).

An evolutionary perspective can help us understand the nature of the virus, our own nature in responding to its threats, and the interactions between these...an evolutionary approach to the pandemic provides a lens through which we can see which strategies a virus might use, which strategies we possess, and which strategies we need to acquire...

... no human, anywhere, is unaffected by COVID-19.

To understand the virus and our response to it, we need to understand how viruses and humans evolve. We know that there is a long history of the coevolution of viruses and humans.

As we can see in the opening quoted sentence, “Nothing in biology makes sense except in the light of evolution” this is the creed of the materialists and atheists. Whereas what we say is that nothing makes sense in biology (or in all of creation) except through the meanings of Allāh’s Names and Attributes.

The authors speak of an “evolutionary arms race between humans and viruses” which nicely characterises what we are witnessing today of pharmaceuticals claiming to have “mRNA software” technology by which they can train the body to combat the “Darwinian Covid-19 virus”, the underlying assumption being that the poor human body was created haphazardly through mutation and selection, just like the virus itself, but the virus has an edge because its evolutionary rate is faster, and thus, we must program and train the body to also “evolve” through “self-directed evolution”, namely a vaccine, so it can keep pace with the Darwinian virus.<sup>28</sup>

They even speak of “which strategies a virus might use”, making it sentient, animating it and conferring it with intelligence and planning, and in turn speaking of the intelligence humans need to use to combat it.

Just like Hoodbhoy, the Pakistani atheist, these authors say in meaning that to understand the Darwinian virus and combat it, an understanding of the long history of coevolution is essential. In other words, we can’t do the science to defeat the virus except upon the foundations of Darwinian evolution.

Thus, when you read in the news articles things like: “The heavily mutated such and such variant has led to a serious setback in our ability to protect ourselves through the vaccine”, then you will better understand what is going on. Everything taking place is wholly Darwinian in nature.

They have drawn us into this false narrative through their speculative materialist sciences, and although it is a hard and bitter pill to swallow, our behaviours are in fact, to some degree, being driven by this narrative, whether we like it or not.

And all we can say is that the Messenger (ﷺ) came with the most perfect, complete and sufficient guidance in this affair, for if the Darwinian virus was true, and Allāh knows best what He created, then surely there would be guidance in what He revealed to His Messenger (ﷺ) that protects the beneficial interests of His servants with respect to this matter. He advised people to keep away from the leper and the owner of sick camels not to pass them by healthy camels in order to protect people from exaggerating in the causes and confusing coincidence with causation, being led thereby to omens and superstition and baseless belief in contagion.

Abū Dharr (رضي الله عنه) said: “The Prophet (ﷺ) left us while there was not a bird flapping its wings in the air except that he would mention to us knowledge regarding it.”<sup>29</sup>

It is not presumptuous to say that if there was such a thing as a “Darwinian virus” that would somehow wreak havoc upon mankind through routine, ordinary day to day contact **between perfectly healthy people**, surely the Prophet (ﷺ) would have given us knowledge, guidance or practical instruction in relation to it.<sup>30</sup>

For if he taught us the etiquette of relieving ourselves, then surely he would have given us guidance in this affair.

**Ibn Rajab al-Hanbali** (رحمته الله) said: “And that which is legislated is the avoidance of what is apparent [of these harms] and to take caution to the extent that is related in the Sharīʿah, such as taking caution from the leper, the sick person, and from going to a place of the plague. As for when the [harm] is hidden [obscure, not apparent], then it is not legislated to take caution and to [seek to] avoid it, because that is from the prohibited omen, and harbouring omens is from the actions of the people of shirk and kufr.” Laṭāʾif al-Maʾārif (Dār Ibn Kathīr, 1420H) p. 142.

On the contrary, he ordered us to visit the sick—this being a collective obligation in the view of scholars—and he told us that sneezing is a blessing and mercy, in contrast to the misguidance of the Pagans who treated it as a disease and an omen<sup>31</sup> and he would enter upon people suffering from fever, and tell them that it is cleansing and purification, and he forbade people from leaving the land of plague out of fear of plague and death specifically, but not for other reasons.<sup>32</sup> And all of this clashes with the speculative theories that the Darwinian materialists have brought to us through their imaginary, fabricated notion of a “virus”.<sup>33</sup>

What has preceded will help you grasp the realities more clearly. You will understand the reality of the alleged mutants and variants that are being used to scare people, and how the pharmaceuticals, those selfless saviours of humanity, are engaged in an “arms race” against the Darwinian virus, and how exaggeration in this imaginary thing evokes fear that can be manipulated for business and profit and other purposes too, and how this has an impact on human behaviour, and for Muslims, there are implications for our beliefs, thoughts, statements and behaviours.

Herein lies the danger of being affected by the materialist pseudosciences of the disbelievers, and in history, there have been times when Muslims were influenced by the sciences of

the Greeks by way of example and some of them of these influences also crept into issues of creed, showing the danger of this topic.

Most Muslims reject Darwinian evolution of course, this is something basic and natural. However, even then, many may not be aware that despite rejecting it, its foundations and subtleties persist to a degree that can affect thought and behaviour if a conscious and concerted effort is not made to understand how it penetrates the biological sciences and is used to build and drive narratives that influence thoughts and behaviours.

## 6. Disease As A Byproduct Of Haphazard Viral Evolution

This is a piece from the Cold Harbor Spring Laboratory in an article titled “**The non-human living inside of you**”.<sup>34</sup>

**Half of your genome started out as an infection; if left unchecked, some parts of it can turn deadly all over again.** The human genome contains billions of pieces of information and around 22,000 genes, but not all of it is, strictly speaking, human. Eight percent of our DNA consists of remnants of ancient viruses, and another 40 percent is made up of repetitive strings of genetic letters that is also thought to have a viral origin. Those extensive viral regions are much more than evolutionary relics: They may be deeply involved with a wide range of diseases including multiple sclerosis, hemophilia, and amyotrophic lateral sclerosis (ALS), along with certain types of dementia and cancer.

If you have read the earlier footnote on “retroviruses” the above will make more sense to you.

Basically, almost half of our DNA genome is alleged to be “viral”<sup>35</sup> in nature and though it is an alleged “evolutionary

relic”, meaning leftover archived DNA, it is responsible for certain diseases which are seen as byproducts of a defective, haphazard, undirected process of Darwinian evolution, through mutation and selection, leading to “bad genes” being integrated into the human genome. Thus, these (and other) diseases are consequences of evolution itself and are proof of it, and man is now in a position to start addressing the inherent flaws in man’s creation by Darwinian evolution through “Darwinian medicine”, one of which is to hack into the “software of life” (mRNA) and engage in “self-directed evolution” to improve this haphazard product of undirected natural selection which is the human body.

However, all of this is pure falsehood. The whole notion of the post-1950s “virus” is false and it is wholly Darwinian in nature.

the disbelievers in principle about the semi-living Darwinian virus that invades, hijacks, replicates and so on.

## 7. The Pandemic As A Real Time Validation Of Evolution

Then this piece from the NC State University titled “**A Primer on Coronavirus, Variants, Mutation and Evolution**”.<sup>37</sup>

When Charles Darwin first wrote about the law of natural selection, he imagined that the evolution in response to selection would be slow. Humans would be left, he thought, to study the consequences of natural selection but unable to see the process in real time. It would have delighted Darwin to know that in this way that he was wrong. **The good news is that the consequences of natural selection, evolution and even the origin of species can be observed in real time. This is true... with regard to the virus that causes COVID-19.** Much as the finches, now called Darwin’s finches, evolved after having arrived in the Galapagos Islands, the virus that causes COVID-19 is evolving rapidly as the virus continues its global spread.

Thus, if you are going to say, “I believe there is a virus, but Allāh is the one who created it” and you affirm this alleged “virus” upon the way it is presented, a “pathogenic” semi-living entity that invades, hijacks, replicates, causing disease, then you are in a bit of a pickle.

Whereas the one who says...

“I believe Allāh created Ādam through the process of Darwinian evolution (mutation and selection), so I am combining between both things, accepting (alleged) scientific reality and a Creator.”

... is speaking of something in the distant past, a process of alleged evolution and natural selection he never saw and which is from the unseen, the one who says...

“I believe there is a virus, but Allāh made it work that way.”

... then he is—unwittingly of course, and without really knowing the implications of what he is saying—**affirming, in real time, in the present, right now**, the mechanism being used by the Darwinists, Atheists, Materialists as living, observable proof for the rejection of a Creator and proof of “evolution in action under our noses”.

This situation has arisen because in the materialist sciences of the disbelievers, the whole of biology has been constructed upon Darwinian evolutionary theory, and they treat Darwin as the founder of the science of modern biology itself. ## 8. Darwinian Medicine And Turning Men Into Gods

Here is a piece on “Darwinian medicine” from the Western Journal of Medicine, “**How is Darwinian medicine useful?!**”.<sup>38</sup>

Evolution by natural selection has been biology’s organizing principle for more than a century, but only in the last few decades has it been applied to the social sciences and medicine. Its application to medicine, known as evolutionary or Darwinian medicine, uses an evolutionary perspective to understand why the body is not better designed and why, therefore, diseases exist at all.

An evolutionary approach can fundamentally change how we think about the body and disease. Instead of seeing disease as a defect in a previously perfect machine, **Darwinian medicine allows us to see the body as a product of natural selection, full of trade-offs and vulnerabilities that all too often lead to disease.**

Everyone uses metaphors to understand the world. The dominant metaphor for the body has been a machine. Disease has been viewed as a defect arising in an otherwise perfect device. An evolutionary view offers a richer and more nuanced view of the body as a product of natural selection: extraordinary in many ways, but also flawed in many ways, for good evolutionary reasons.

Thus, it is not that Allāh created the body upon homeostasis and equilibrium, created perfectly for its intended purposes<sup>39</sup>

but it is—by necessity of being a product of natural selection—inherently flawed, and this is how disease arises. It is due to the vulnerabilities that have arisen due to the haphazard way it has evolved—in an undirected manner—and despite having adapted, it still retains many flaws. Derived from this is the concept of “Darwinian medicine” which is applied upon this understanding.

This is the basis upon which the disbelievers assert today that they can “hack” into the “software of life”—that is, mRNA—and engage in truly “intelligent design”, not the alleged “intelligent design” of a “god above the clouds” as is said by one of their priests, Yuval Hariri<sup>40</sup>, but real intelligent design.

They believe that the era of haphazard, undirected evolution by natural selection is over and now man can take over and engage in actual intelligent design to iron out all the flaws in haphazardly created biological life and to unlock the secrets of ageing and immortality.

In his article, **“Forget natural selection: go with intelligent design”**, Hariri writes:<sup>41</sup>

Religious fundamentalists believe that life is the product of intelligent design rather than natural selection. As far as the past goes, they are completely mistaken. But when it comes to the future, they are most probably right. The four-billion-year-old reign of natural selection is coming to an end, and in the future, life in the universe will increasingly be shaped by the designs of intelligent godlike beings. Us. Sort of.

We humans are in the process of upgrading ourselves into semi-divine entities, and acquiring for ourselves unprecedented abilities of creation by design. This is not merely the greatest revolution in thousands of years of history, but also the greatest revolution in billions of years of biology.

When they come to write the definitive story of life, it will go something like this: “About ten billion years after the Big Bang, life appeared on Earth. For four billion years natural selection tinkered with it this way and that, but nothing really important happened. And then, around 2050, intelligent design took over.”

This priest and wizard for the disbelieving elites, the allies, followers and worshippers of Iblīs, also said in his 2017 lecture, **“How Technology Will Turn Men Into Gods”**:

When I say that humans will try to upgrade themselves into gods in the 21st century this is not meant as a metaphor I mean it

literally... Today modern science is doing much better than the Hebrew God ...

Given the tremendous changes were facing already today in the world you see a lot of people trying to cling to some eternal story like God or like the nation but this is unlikely to really stop the change in the world or to shape the 21st century because these stories don't offer us answers to the big problems of the 21st century.

The big problems of the 21st century are things like what to do when you can start designing babies with biotechnology what to do when artificial intelligence is pushing humans out of the job market and you have this massive useless class what to do when humankind is being split into different biological castes.

Now you don't find answers to any of these questions in the Bible or in the Quran because the people who wrote these books back in ancient times did not know anything about artificial intelligence or about genetics so it's obvious they don't have the answers there.

If you need answers you need to create new ideologies new religions and in the same way that in the 19th century we saw the creation of new ideologies like socialism and they really changed the world so I think in the 21st century will again see the rise of new ideologies and religions coming not from the Middle East but from places like Silicon Valley and they will shape our world much more than the fanatics of the Islamic state.

The most important I think at least at present is data-ism a religion or ideology which worships data and not God and not humans basically what data is insist is that given enough biometric data and given enough computing power, an external algorithm can understand me better than I understand myself and once we have that, an algorithm, authority will shift away from individual humans to these algorithms.

So in the same way that authority at first was with the gods above the clouds and then in modern times authority shifted below the clouds to human beings now authority will shift again back to the clouds, but to the Google cloud to the Microsoft cloud this is where authority in the 21st century will be and all the

important decisions will not be made by the Pope or by God they will not be made by democratic elections and by individual consumers they will be made by the algorithms in the cloud.

Hariri's works strongly reflect the current ideology and future agendas of the Malthusians and Eugenicists among the disbelieving elites for whom he writes and speaks.

## 9. 20<sup>th</sup> Century Materialist Pseudoscience Returning People To The Medieval Dark Ages Of Superstition

Then, there is this piece from the Proceedings of the National Academy of Sciences, “**How the unvaccinated threaten the vaccinated for COVID-19: A Darwinian perspective**”:<sup>42</sup>

In 1859, Charles Darwin published *On the Origin of Species*, in which he outlined the principles of natural selection and survival of the fittest. The world presently has the unwelcome opportunity to see the principles of evolution as enumerated by Darwin play out in real time, in the interactions of the human population with SARS-CoV-2. The world could have easily skipped this unpleasant lesson, had there not been such large numbers of the human population unwilling to be vaccinated against this disease.

SARS-CoV-2 has shown that it can mutate into many variants of the original agent. An unvaccinated pool of individuals provides a reservoir for the virus to continue to grow and multiply, and therefore more opportunities for such variants to emerge. When this occurs within a background of a largely vaccinated population, natural selection will favor a variant that is resistant to the vaccine.

So far, we have been lucky that the variants that have emerged can still be somewhat controlled by current vaccines, probably because these variants evolved in mostly unvaccinated populations and were not subject to selective pressure of having to grow in vaccinated hosts. Nevertheless, the Delta variant is exhibiting increased frequency of breakthrough infections among the vaccinated.

The real danger is a future variant, which will be the legacy of those people who are not getting vaccinated providing a breeding ground for the virus to continue to generate variants. A variant could arise that is resistant to current vaccines, rendering those already vaccinated susceptible again.

Progress we have made in overcoming the pandemic will be lost. New vaccines will have to be developed. Lockdowns and masks will once again be required. Many more who are currently protected, especially among the vulnerable, will die.

This dire prediction need not occur if universal vaccination is adopted, or mandated, to protect everyone, including those who are already vaccinated.

Darwinian selection may also yet solve the problem with a much crueler calculus. The unvaccinated will either get sick and survive, and therefore be the equivalent of vaccinated, or they will die and therefore be removed as breeding grounds for the virus.

This does not really require much commentary except to say that the “Darwinian virus” is being combatted by the “Darwinian vaccine” as part of an ongoing evolutionary struggle and the people of the earth have been caught in this narrative it appears, which originates with the Materialists, Atheists, Malthusians, Eugenicists and Communists.

And they say that it is the unvaccinated who are the real enemy because they are not allowing the war against the Darwinian virus to proceed effectively, allowing the enemy to continue to breed variants, serving the enemy thereby, effectively becoming traitors, allying with the Darwinian virus against mankind. Thus, they must be penalised and punished if the evolutionary war is to be won against the enemy. This

narrative, as you have seen is not an imaginary one, it is a real narrative being spoken of and pushed and it is being turned almost into a creed by the people of disbelief, which if you oppose, it is as if you are an enemy to mankind.

Rather, it has been given an overt Communist flavour as can be seen by insidious slogans of propaganda such as: “We are all in this together”, “The war is not won until everyone is vaccinated”, “I wear my mask for you”, “I took the jab for my gran” and so on.

These slogans have been devised by behavioural psychologists and are aimed social engineering through the generation of guilt and charges of criminality and harm to the “community”. The ignorant, common people are then mobilised against those who see through and do not fall for this propaganda, and who are treated as enemies of the collective. This is something that is evidently and openly taking place in the Western lands of disbelief.

## 10. Ramblings Of A Bangladeshi Atheist

Reflect upon what this Bangladeshi atheist and outspoken critic of Islām and the Sharīʿah, Taslima Nasreen, writes, making mockery of religion in general while praising the Darwinian scientists and the “saviour of mankind” vaccine:<sup>43</sup>

Clerics are no longer claiming they will go to the mosques and pray before Allah to save people from the virus<sup>44</sup>... the businessmen of religion know very well that Allah will not save us from the novel coronavirus.<sup>45</sup> If anyone can, it's the scientists, who are busy finding a vaccine, a cure.

It's been nearly 160 years since Charles Darwin disproved the existence of god by his theory of evolution. Humans were not made by a Creator, they evolved from apes.

So, the facts as they stand now are clear: diseases are not cured by Allāh, God or Bhagwan; diseases are cured by scientists. Human beings are not saved by supernatural powers but by other human beings. Religious people are no longer waiting for benevolence from their respective gods; they are waiting for a vaccine.<sup>48</sup>

In essence, she is claiming the cure lies in a vaccine from scientists who operate upon Darwinian evolutionary biology, and it does not lie with God, since Darwinism has disproved God. Her physical evidence is that religious people have closed their mosques, churches and temples out of fear of the Darwinian virus and have turned completely and

wholeheartedly to Darwinian medicine (as she sees it) for the cure. She is able to say this because the whole world has in fact somehow been led to believe that only a vaccine can defeat the alleged “Darwinian virus” and bring “normality” back to people’s lives.

This is also what Hoodbhoy was alluding to in what we cited from him earlier: “All beneficiaries of modern medicine should surely forgive Darwin for his supposed transgressions.”

## 11. “Crass Deviated Sciences”

By now we should be able to appreciate the speech of **Shaykh ‘Abd al-Raḥmān bin Nāṣir al-Sa’dī** (رحمته الله) cited at the beginning of this treatise, when he said:<sup>49</sup>

Ideas and sciences alone without a heart that pursues goodness and truth is not sufficient by itself. Rather, their harm can be plentiful due to them being devoid of īmān, being devoid of sound guidance, and due to the people [of these sciences] being arrogant on account of them...

So look at their sciences which were not founded upon īmān, rather they were crass, deviated sciences which became a reason for them to oppose the Messengers and for them to remain upon what they are of disbelief and rejecting the truth, so we seek refuge in Allāh from knowledge that does not benefit.

Given what has preceded, we should make a distinction between these two situations:

—**a**) If you hold that there is a “virus” expelled by a sick person with the meaning of **something noxious or toxic**, just like any other noxious thing, and you affirm contagion, that Allāh can make another person ill through this, thus you wish to keep away from a sick person, then that is fine.

The dispute with you is simply the labels.

Your acceptance of the labels of the non-Muslims in their sciences is the cause of confusion given that they have co-opted the “virus” label and entered their modern-day virology

pseudoscience fraud and Darwinian baggage into it, based upon their misinterpretations of observations and false theorisations.

Ideally, you should drop the “virus” label altogether and simply say:

“A sick person expels what is dead, noxious, waste material and toxins that the body is expelling as it is designed to do so through Allāh’s creational decree and wisdom whenever there are causes and factors that necessitate that. And I’ll just keep away from a sick person to avoid general harm since it is natural to be averse to being in the presence of a sick person displaying symptoms, and to avoid a potential cause of disease [if you hold that view of contagion].”

This has no connection to the pseudoscience of virology and here you are in a safe area. The only issue is that of the dubious label (“virus”) employed by the disbelievers and the use of these labels perpetuates confusion and feeds into their pseudoscience.

—b) If you hold that there is a “virus” upon what the disbelievers allege, upon the pseudoscience and fraud of virology, which is the notion of a semi-living entity that invades, hijacks, replicates to generate illness<sup>50</sup>—[and this in turn incorporates the notion of “mutation and selection” arising thereafter]—in which the disbelievers are misguided, as they have simply made gross misinterpretations of what is actually going on during an illness, overturned realities, confused effects with their causes, and employed fraud, deception, sleight of hand trickery in laboratories and so on, with all of that resting upon their Darwinian conceptions, then

here, you are in the grey area.<sup>51</sup> Likewise, if you accept the notion of “variants” and “mutants” then you have bought into the neo-Darwinian fable.

The reality is that you cannot say here: “Allāh did it like this, Allāh created this type of so-called ‘virus’ which works in this way”, because the conception of the virus is wholly Darwinian from beginning to end, inseparable from it.

It would be like saying, “Allāh created Ādam through evolution”, wherein you are unwittingly affirming the mechanism (mutation and selection) which is the false, unproven foundation they use for rejecting a Creator.

Likewise, when you say, “Allāh created the virus and made it behave the way it does”, then you have just accepted the speculations of the naturalists, atheists and simply added the label of “Allāh did it this way”, but this does not make it become true.

Given the above, it is necessary for the distinction to be made between

—The perception of the people of Tawhīd and Īmān in these affairs, how to view health, disease, cure, tied to Allāh’s Names and Attributes, and the biological meanings, purposes, end-goals and wisdoms in things, in disease and its symptoms, all of which are a witness to Allāh’s Rubūbiyyah and Ulūhiyyah<sup>52</sup>, and

—What is with the Materialists, Atheists and Darwinists of their misrepresentation of what Allāh created and in which

they wander blindly in the dark, rejoicing with what they have of what they think is knowledge, when it is misguided speculation, and the excessive, unwarranted behaviours built upon this.

Likewise, to show the difference between the guidance of the Messenger of Allāh (صلى الله عليه وسلم) which came to put an end to superstition and omens, baseless fear, and the exaggeration of the polytheists in the matter of contagion, and what is with the disbelievers, polytheists, atheists and materialists of gross exaggeration in this regard, built upon their false, misguided theories in which they reverse realities.

## Closing Notes

The pseudoscience of “Virology” is inseparable from Darwinian evolution and it is a wholly fraudulent enterprise, having been built initially on misunderstandings and misinterpretation of observations. It is a pseudoscience based on linguistic fraud, sleight of hand trickery in the laboratory, genomic sequencing fraud, and violation of the basic principles of scientific method.

This means that claims of viral contagion do not have any genuine scientific basis. This was already known and proven in the early 20<sup>th</sup> century, but from the mid 20<sup>th</sup> century onwards, in order to cling to the idea, linguistic and laboratory sleight of hand tricks were employed to keep the illusion going.

Samples from patients—allegedly containing the virus—and which contain debris of human cells, mitochondria, bacteria, fungi and archea are immediately placed in a “viral transport medium” that contains serum from other animals and is then cultured in a monkey kidney epithelial cells which are kept alive with bovine serum. To this mixture, harsh antibiotics are added while the serum that keeps the cells alive is withdrawn, the cells start dying and this is supposed to be proof that the virus exists and has been “isolated”.

This is the basic procedure that has been in use since the 1950s, it is nothing but the sleight of hand trick of a magician.

Genomes are then constructed through sequencing of other nucleic acids found in this hotch-potch of human, bovine, monkey, bacterial, fungal, archeal breakdown materials. Computer software is used for so-called “alignment”. It is through this process that families of alleged viruses are constructed. **It is a falsification of reality and mere simulation through computer software.**

This is an entirely fraudulent enterprise. There is no “virus” and it is always the experimental procedure that is the real cause of the effect on the monkey kidney cells. Genetic debris, proteins and microvesicles are being picked up and theorised into a “virus” particle.

This has now been thoroughly and definitively exposed, the fraud has been uncovered and laid bare, and there is no escaping this reality.

All of what has preceded is what leads to this series of being written, and this in turn rests upon scholarly insight such as the following from Shaykh Sulaymān bin Ḥamdān<sup>53</sup> (رَحِمَهُ اللَّهُ) (d. 1397H) who said:<sup>54</sup>

وبالجملة: فليس فيما بعث الله به رسوله صلى الله عليه وسلم ما يكون سببا للشر أصلا، بل كل شر أصاب العبد أو يصيبه في دنياه وآخرته، فسببه الذنوب والمعاصي.

In summary, there is nothing at all, in what Allāh sent His Messenger (صَلَّى اللَّهُ عَلَيْهِ وَسَلَّمَ) with, what is a means to evil. Rather, all evil that afflicts a servant, or afflicts him in his worldly affairs or the hereafter, then its cause is sins and disobedience.

... And whatever He wills to occur will occur and whatever He does not will to occur, will not occur. And He, the Sublime, is the Creator of the causes and their effects, there is no Creator besides Him and no Determiner besides Him. The servant is ordered to take caution against the apparent causes of evil and to avoid them to the extent that is related in the Sharī'ah, such as taking caution from the leper and the sick person and from going to a place of the plague. But as for what is hidden [obscure, not apparent], then taking caution against it and avoiding it is not legislated. Rather, it is from the prohibited omen, and indeed, it is having an evil opinion of Allāh the Exalted, without any verified cause. Hence, it is not permissible.

That which is obligatory upon he who wishes good for himself is not to turn towards anything from these false imaginations and deceptive delusions and [instead], to be preoccupied away from them with what repels calamity, such as supplication, remembrance, charity, reliance upon Allāh and belief in His ordainment and decree. And [to know]



that whatever He wills to occur will occur and whatever He does not will to occur, will not occur and to say what is related, and from it is:

*“O Allāh, none comes with the affairs of good but you and none repels the affairs of evil but you, there is no power, nor might, save by You.”* [Related by Abū Dāwūd, no. 3919].

So when he says that, nothing will harm him.

As for when he surrenders [himself] to these affairs, and opens the door of whispers to his soul in these affairs, or [opens the door to his] worries to Shayṭān and throws of such things into his soul what corrupts his religion and makes his life difficult [with hardship, misery], and perhaps that which he took caution against might befall him as a punishment [for holding an evil opinion and harbouring omens].

It outlines very well the perfection of the guidance of the Messenger (صَلَّى اللّٰهُ عَلَيْهِ وَسَلَّمَ) in this issue which is simple, clear cut, deals with physical reality, and does not contain burdens and shackles and what exceeds the bounds and enters into the realms of suspicions, baseless fear, exaggerations, evil opinions, superstitions, omens and all associated toils and hardships, the very ones which the Prophetic guidance came to relieve and protect us from.
